

Judgment of General Term, affirming judgment for plaintiff, reversed, and new trial granted. Opinion by Danforth, J. All concur, except Earl, J., not voting. MORTGAGE. N. Y. Court Of Appeals. Coles, respt., v. Appleby, applt. Decided Nov. 22, 1881. The mortgagor conveyed part of the premises in suit to B., giving him sufficient money to pay off the mortgage. B. paid the same to the mortgagee, but having occasion to procure the satisfaction of a mortgage for a like amount, held by said mortgagee against A, he caused the bond and mortgage in suit to be assigned to the mortgagee, in substitution of the A. mortgage. This occurred previous to appellant s interest in the premises, which he acquired as B. s grantee. It was shown that B had said he would pay the mortgage, and afterwards certified on making a loan from appellant that the property was free and clear. Held, that there was a sufficient consideration for the assignment to plaintiff, and that the evidence tended to establish an intention to keep this mortgage alive as an existing and valid security. Affirming S. C, 10 W. Dig., 532. This action was brought to foreclose a mortgage, made May 11, 1868, by one J. to one C., to secure the payment of \$600 in one year, which was assigned by...
